

RESOLUTION NO. 93-3

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DALY CITY  
AMENDING CITY COUNCIL RESOLUTION NO. 90-32,  
"ESTIMATING COSTS OF CANDIDATE'S STATEMENT AND PROVIDING  
SAME SHALL BE PAID IN ADVANCE"

1. The City Council of the City of Daly City heretofore adopted Resolution No. 82-7 on January 4, 1982, Resolution No. 82-159 on June 28, 1982, and Resolution No. 90-32 on January 22, 1990, "Estimating Costs of Candidate's Statement and Providing Same Shall be Paid in Advance".

2. As the City of Daly City is facing a Special Election this year and a General Election in 1994 and in the past the cost of printing candidate statements for the sample ballot exceeded the revenue, City Council Resolution No. 90-32 should be amended to increase the cost of the candidate statement, among other things.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Daly City that it does hereby amend Resolution No. 90-32, to read as follows:

"1. Elections Code Section 10012 provides that a City may estimate the total cost of printing, handling, translating and mailing the candidate's statements filed pursuant to this section, and may require each candidate filing a statement to pay in advance to the local agency his or her pro rata share as a condition of having his or her statement included in the voter's pamphlet.

2. The Statement of Qualifications that a candidate may prepare shall be in the form authorized by Section 10012 of the Elections Code of the State of California and shall not exceed two hundred (200) words.

3. The City Clerk has estimated the costs of printing candidate's statement to be in excess of monies collected.

4. The City Clerk has established that an unknown number of candidates will have filed for office and, therefore, the pro rata share of costs will be \$500.00.

5. The City Clerk is authorized by the Elections Code to refund any excess over the actual costs of printing, handling, translating and mailing the candidate's statements.

NOW, THEREFORE, each candidate for an office at a general or special election filing a candidate's statement shall pay in advance his or her pro rata share as a condition to having his or her statement included in the voter's pamphlet.


BE IT FURTHER RESOLVED that in the event actual costs are less than collected, the City Clerk is authorized to refund the excess on a pro rata basis."
