The artists and the artist dialogues have taught us a lot about the work we can do via Zoom.

Should we include the reorganization of A&C Commission in December so it coincides with the City Council Reorganization.

Leilani will advise us at the next meeting as to whether we can set a date for reorganization.

VI. Measure Q- how can we play a role in advising City Council. For every dollar spent it is a half cent of every dollar spent until it is repealed. Fire services and paramedic services have been big. Maintaining city's financial stability is a big one. Maintaining services for our most vulnerable populations like our seniors. Keeping our streets and city safe and clean.

That is why measure was around recovery and relief. It is an emergency measure. We won't see revenue for a while.

It is projected that it will get us \$6 million per year.

Can city define scope for each of these priorities.

Who else is considered vulnerable communities? Youth, homelessness, mental health concerns, disabilities, etc. Who is the most marginalized. Who is in charge of this fund? City Council.

Racism, classism and oppression contribute to people's mental health issues.

Perhaps we can work on the safe and clean part of this measure. Leilani expressed her wish to have an art piece done to promote clean communities.

How about creating an historic district in original Daly City.

Joanne and Nancy will work with Leilani to see if we can get some history to support clean and safe communities.

VII. Programming from January through March. Artist can come in March. Let's think who we would like to bring in January and February. Joanne has been in contact with Christian Kabay. He can do a workshop on Babayan writing workshop. It will be from 7:00 to 7:45. Joe will facilitate. Dorie do you want to share that video at the beginning of the event? Dorie might look for another performance. Tentative. Dorie said she would get the Filipiana fashion show for February 9. On March 9, we will feature Felicita Norris. Elizabeth get a bio and 40 description for their Instagram. Then it is about promotion.

Update on video with library- after downloading app. you can bring your phone to the screen and it will tell a story about the painting. The video is really cool. There is music to it. Artist Angely Clarisse.
