All comments received by 4:00 pm will be emailed to the Arts and Culture Commission members prior to the meeting. Those comments received after 4:00 pm will be added to the record and shared with the Arts and Culture Commission members following the meeting.

To speak at the meeting, you must register to join via Zoom. The City requests that you complete your registration by 5:00 pm on the meeting date. After registering, you will receive a confirmation email containing instructions on how to join the meeting, including a unique link. Your email will not be disclosed to the public. Public comment is limited to two minutes maximum.
