When I mention “the unit block” of a street, this means the incident occurred at an address anywhere between 1 and 99 of the street.

Notable Cases

On Monday, 05-29-17 at approximately 8:42 p.m., Officer Todaro and Officer Perdomo were dispatched to an apartment on the unit block of **Coronado Avenue** on a report of an unknown subject looking through the window and knocking on the door of the reporting party's apartment. The reporting party said the subject asked if someone by another name was there, and the reporting party said no one was there by that name and closed the door. A couple of hours later, the reporting party's roommate saw the same subject in front of the apartment door. The subject fled the area but was found by Westlake Security. The subject, a 29 year old Daly City resident, was arrested for disorderly conduct.

On Tuesday, 05-30-17 at 11:02 a.m., Officer Haas and Officer Shiu were dispatched to the Planet Clean laundromat on **School Street** on a report of a verbal argument between people outside the laundromat. Officer Haas asked a male subject to have a seat on staircase, and as the man walked to the staircase, Officer Haas saw him reach into his pocket and throw a small cellophane bag onto the staircase. The subject, a 38-year old Daly City resident, was cited for possession of a controlled substance and for trying to conceal the evidence by throwing it onto a staircase.

On Wednesday, 05-31-17 at 2:05 a.m., following a traffic stop by Officer Poti at the intersection of **Mission Street** and **Westlake Avenue**, a 40-year old San Francisco resident was placed under arrest for driving under the influence of a controlled substance, being under the influence of a controlled substance, possession of a controlled substance and for possession of unlawful paraphernalia.

On Wednesday, 05-31-17 at 12:38 p.m., two 16-year old South San Francisco residents were arrested for vehicle burglary, conspiracy to commit a crime, resisting a police officer, an adult offense being committed by a juvenile, possession of burglary tools, appropriation of lost property and possession of less than 28.5 grams of marijuana. This occurred at the parking lot of 2001 **Junipero Serra**

Boulevard. One suspect was charged with two other auto burglary cases at the parking lots on both sides of the theater.

On Wednesday, 05-31-17 at 10:36 a.m., officers were dispatched to the **Krispy Kreme** on a report of a female in her 50's who was yelling at everyone inside and refusing to leave the premises. Officers made contact with the female and advised her that if she didn't leave, the store manager would like to have her arrested for trespassing. The suspect agreed to leave the building.

On Saturday, 06-03-17 at 1:00 p.m., a 13-year old Daly City resident was arrested for battery on an officer after he scratched an officer and resisted arrest. This occurred at **T.R. Pollicita School**.

On Saturday, 06-03-17 at 6:55 p.m., Officer Hyink placed a 31-year old Montara resident under arrest for driving under the influence of drugs after he found the subject was asleep behind the wheel and blocking traffic on **John Daly Boulevard** and **Junipero Serra Boulevard**. The subject was also in possession of .28 grams of methamphetamine, used hypodermic needles containing heroin, counterfeit \$100 bills, and a credit card embossing machine which included a laptop connected to a credit card reading apparatus. The subject also possessed multiple California driver's licenses and altered credit cards.

Robberies

There were three robberies during the past week.

On Thursday, 06-01-17 at 7:30 p.m., a 30-year old Daly City resident met at a gas station on **Sullivan Avenue** to meet with an individual to purchase two Apple Macbooks and some Apple iPhones from a subject who was selling them on Craigslist. The victim said the subject pulled up in a cab, and they conducted the transaction in the victim's vehicle. The victim said the suspect then held a pocket knife and took the victim's money. The victim said the subject got back into the cab and drove away. This case is referred to investigators.

On Friday, 06-02-17, a 51-year old San Francisco resident said he was on the south side of John Daly Boulevard towards Westlake Shopping Center walking with a push cart containing his belongings when he stopped to urinate at a bush between **South Mayfair Avenue** and **John Daly Boulevard**. He said he sat down on a bench when an unknown suspect approached him, pulled out a knife and demanded his money. The victim said he refused but became fearful of his life and gave the suspect approximately \$1.75. The victim described the suspect as a dark skinned male, approximately 25-30 years old, 6'0", 170 pounds, dark curly hair, wearing a red and white jacket, white or turquoise tee shirt, white jeans and had a white backpack.

On Saturday, 06-03-17 between 6:20 p.m. and 6:45 p.m., the **Safeway** manager was the victim of a robbery by two unknown subjects after she was pushed after trying to stop the subjects for stealing soaps and lotions. The two subjects fled in a red Honda Civic. The manager was unharmed.

Residential Burglaries

There were no residential burglaries during the past week.

Commercial Burglaries

There was one commercial burglary during the past week.

On Sunday, 06-04-17 at 4:51 a.m., the Connect Consignment store on **Mission Street** was burglarized by an unknown suspect who smashed the front display window and took a cash register, Sony laptop and two pairs of basketball shoes. This investigation is continuing.

Vehicle Burglaries
