When I mention “the unit block” of a street, this means the incident occurred at an address anywhere between 1 and 99 of the street.

Notable Cases

On Tuesday, 11-28-17 at 12:52 a.m., a 38-year old Daly City resident said she received criminal threats via text messages by a woman who is dating her former boyfriend. The woman sent a photo with a gun, followed by a threatening message. On Saturday, 12-02-17 at 8:40 a.m., officers arrested the suspect, a 35-year old East Palo Alto resident, for criminal threats and for being a convicted felon possessing a firearm.

On Tuesday, 11-28-17 at 7:39 a.m., Officer Dhaliwal and Officer Bocci responded to a report of a vehicle with a heavy smell of marijuana blocking the driveway at a residence on the 400 block of **Wyandotte Avenue**. Officer Mulitaupopele and Officer Aquila were already on scene and talking to the subject. Officer Dhaliwal observed moderate damage and a flat tire to the vehicle. Officer Aquila said the driver was asleep when he made contact with him. The driver admitted to taking Xanax in order to fall asleep and told the officer he was not drinking alcohol. The officer found three jars of marijuana in the subject’s vehicle and subsequently conducted field sobriety tests on the driver. After failing the tests, the driver, a 21-year old Daly City resident, was arrested for driving under the influence of drugs.

On Wednesday, 11-29-17 at 6:19 p.m., Officer Jackson-Berrios responded to a burglar alarm call to a residence on the 200 block of **Alta Loma Avenue**. The alarm company reported that the responsible party provided an incorrect pass code. The officer rang the doorbell, and the resident answered the door. The officer asked the resident for his driver’s license, and when the resident went to go retrieve it, the subject’s dog escaped from the residence, jumped up and attempted to bite the officer in the groin area. The officer instinctively tried to push the dog’s head away with her hand, and the dog bit

the officer's middle finger. The owner was unsure when the dog had a rabies shot, and the officer went to Seton Hospital for treatment. This case is referred to the SPCA.

On Wednesday, 11-29-17 at 6:32 p.m., Officer Todaro was dispatched to a report of a road rage incident that occurred at **Verducci Drive** and **King Drive**. The reporting party said he was cut off by a driver in a silver BMW and honked his horn. The reporting party said the driver of the BMW slowed down, waited for him to drive next to him and waved what looked like a gun at him. The reporting party took down the license plate and gave it to the officer. As Officer Todaro went to contact the owner of the BMW at his residence on King Drive, he saw the owner walking away from the BMW. Officer Todaro asked the subject if he was involved in a road rage incident with another vehicle recently, and the subject said he was cut off a couple times by a car a few minutes prior. The officer asked the subject if he waved any type of weapon or firearm at the other vehicle, and the subject denied it. The officer asked the subject if he could search his vehicle for weapons, and the owner gave consent. Prior to searching the vehicle, the officer asked the subject if there was anything in the vehicle he should be aware of, and the subject said there was "dope" inside a black bag in the vehicle. Inside the bag was a clear plastic baggie containing a solid white crystalline substance that the subject admitted was methamphetamine. The suspect, a 30-year old Daly City resident, was arrested for possession of a controlled substance and for narcotics paraphernalia (glass pipe).

On Thursday, 11-30-17 at 12:54 a.m., Officer McCarthy conducted a traffic stop on the unit block of **Simpson Drive**. The driver attempted to exit the vehicle, and the officer told him to get back into his vehicle. The driver at first refused, but then he got back into the vehicle. As he did that, the subject dropped a small clear plastic baggie containing a white crystalline substance on the street between the driver's door and rear passenger door. Officer McCarthy asked the subject if he had any identification on his person, and the subject said he didn't, but that he stayed at the house he was parked in front of. The subject provided the officer with a name and date of birth, and the dispatchers could not find a match. With the assistance from Officer Fulmore, Officer McCarthy verified the subject's name and asked him if he had any more methamphetamine on his person. The subject admitted he did, and he asked if he could just be written a ticket and not taken to jail. Officer Bermudez arrived on scene and searched the subject and found two additional clear plastic baggies containing methamphetamine, and he found three bullets in two of the subject's pockets. The subject had an ankle monitor on his ankle, refused to answer why he was wearing one and began to shake and sweat. While the officers were speaking to the subject, another subject came out of the garage of the house and said the subject stayed in the garage portion of the house. The officers conducted a parole search of where the subject stayed, and they found three gun cases containing firearms. The 39-year old subject was arrested for having a felony no-bail warrant for a parole violation, a felony no-bail warrant for burglary, being a felon in possession of a firearm, being a felon in possession of ammunition, being a felon in possession of high capacity magazines, being a felon in possession of an assault weapon, transporting a controlled substance, and for driving with a suspended driver's license.

On Friday, 12-01-17 at 9:00 p.m., a 64-year old San Francisco resident was arrested for driving under the influence after she struck a parked vehicle in the area of **Brunswick Avenue** and **Oliver Street**.

On Saturday, 12-02-17 at 8:20 p.m., Officer Ciucci was dispatched to a call regarding a brandishing with a firearm that occurred following a road rage incident at **Sullivan Avenue** and **Washington Street**. The two victims said a subject in another vehicle brandished a firearm at them as they were driving. One of the victims was able to video tape the suspect vehicle and obtained the license plate number. This investigation is continuing. The victims, 28 and 31 year old San Francisco residents, also had their two children (12 and 4 years) in the backseat. No one was physically harmed.

On Sunday, 12-03-17 at 3:31 a.m., Officer Soyangco was dispatched to the 400 block of **90th Street** on a report of a subject who passed out in the back of an Uber driver's vehicle. The subject had a strong odor of an alcoholic beverage emanating from his person. The officer woke up the subject and asked him to sit on the curb. The subject at first did not comply. The officer found the subject's cell phone and asked him to call someone to pick him up, and the subject looked at the officer, threw his phone towards the officer and said, "You figure it out." The 22-year old subject was arrested for public intoxication and was taken to jail.

On Sunday, 12-03-17 at 7:25 p.m., officers were dispatched to the area of the **Boulevard Café** on a report of an auto burglary in progress. The reporting party saw three males trying to break into a vehicle. Officers arrested three males, two 22-year olds and one 20-year old, all from San Francisco, for auto burglary, possession of stolen property and conspiracy.

Robberies

- **24 hour Fitness** parking lot—a makeup kit was taken from a 2017 Subaru Outback. The right rear window was smashed. Occurred on 11-28-17 between 9:00 a.m. and 10:45 a.m. **On-line report made.
- **Serramonte Shopping Center** parking lot near **Target**—a backpack containing a 13" Mac Book Pro, Bose wireless headphones and school paperwork was taken from the passenger side floor board of a 2015 Jeep Wrangler. The left front window was smashed. Occurred on 11-28-17 between 3:30 p.m. and 4:30 p.m.
- 1901 **Junipero Serra Boulevard** parking garage—a suitcase and backpack were taken from a 2007 Audi A4. Both right side windows were smashed. Occurred on 11-28-17 between 9:30 p.m. and 11:30 p.m. **On-line report made.
- **Hickey Boulevard/Callan Boulevard**—Beats headphones were taken from the rear seat of a 2015 Honda Fit. The right rear window was smashed. Occurred between 7:00 p.m. on 12-01-17 and 9:30 a.m. on 12-03-17.
- Unit block of **Poncetta Drive**—a passport was taken from a 2015 Hyundai Accent. The method of entry is unknown. Occurred between 11:00 p.m. on 11-28-17 and 7:25 p.m. on 12-03-17. **Three subjects were arrested for this and other burglaries. (See "Notable Reports".)

Scams/Other

Jury Duty Scam

No one has reported this yet, but since it occurred nearby, it is worth mentioning. The San Mateo County Sheriff's officials are warning the public about a jury duty phone scam involving suspects who pose as sheriff's office employees in an attempt to defraud people for personal information and money. The Sheriff's Office has received calls from victims who were told that they would have to pay a fee for failure to appear for jury duty. They are told to purchase gift cards or pre-paid "green dot cards" or else they would be arrested. Please do not fall for this scam! According to the San Mateo County Sheriff's Office, they will never contact a member of the public and demand that fees be paid via money cards or wiring over the telephone. If you would like to verify your jury duty status, you may do so by calling the Superior Court of California, San Mateo County Jury Division at (650) 599-1700.

Community Events/Information

Household Hazardous Waste Disposal Event—Saturday, December 9, 2017

San Mateo County residents can safely dispose of household hazardous waste (HHW) free of charge on Saturday, December 9 from 8:30 a.m. to 12:15 p.m. only by appointment. Residents are required to schedule an appointment at San Mateo County's HHW program on line at www.smchealth.org/hhw or by phone at (650) 363-4718 and select option 3. You will be given the drop off location after you make your appointment.

Accepted items include acids/bases, aerosol cans, automotive supplies (car batteries, motor oil, antifreeze, brake fluid), cleaning products, fertilizers, pesticides, flammable liquids, fluorescent lights (compact and tubes), paint, inks, and photo chemicals. No radioactive, explosive, medical or commercial waste is allowed. All waste collected is reused, recycled, or stabilized for proper disposal to achieve zero waste being landfilled.

In an emergency situation, an alert will be sent by San Mateo County authorized personnel and you will receive messages on your cell phone or mobile device. This private network ensures that only those who live in your neighborhood can join; users must go through a verification process.
