When I mention “the unit block” of a street, this means the incident occurred at an address anywhere between 1 and 99 of the street.

Notable Cases

On Tuesday, 09-24-19 at 8:37 p.m., **Officer Maddison** and **Officer Jackson-Berrios** were dispatched to the emergency room at **Seton Hospital** on a report of a heavily intoxicated male hitting a security guard. The hospital staff advised that the subject was unruly during his time at the hospital. The subject, a 38-year old San Francisco resident, was arrested for public intoxication. The security guard advised he was not, in fact, hit by the subject.

On Thursday, 09-26-19 at approximately 11:11 p.m., officers were dispatched to the unit block of **Monterey Drive** on the report of a hit and run. The reporting party said the driver was intoxicated and fled the area. Approximately 11 minutes later, another party reported the same vehicle struck a parked vehicle on the 100 block of **Edgemont Drive**. The reporting party saw the vehicle park in a driveway on the 200 block of **Higate Drive**. **Officer Chow** and **Sgt. Busalacchi** arrived on scene and contacted the driver of the suspect vehicle. The driver, a 44-year old Daly City resident, was subsequently arrested for felony DUI with three or more prior convictions within 10 years, resisting arrest, and hit and run.

On Friday, 09-27-19 at 9:15 a.m., a 23-year old Daly City resident was arrested for possession of a controlled substance, possession of drug paraphernalia and for obstructing a peace officer. This occurred following a report of a suspicious subject on the 100 block of **East Moltke Street**.

On Friday, 09-27-19 at 5:52 p.m., **Officer Haas** was dispatched to the **Chinese Hospital** on **Eastmoor Avenue** on a report of a female subject with no apparent medical issues who was in the waiting room yelling at staff members. Officer Haas arrived, and after observing the subject was intoxicated, he placed the 33-year old Daly City resident under arrested for public intoxication.

On Friday, 09-27-19 at 7:24 p.m., **Officer Todaro** and other officers were dispatched to the 6700 block of **Mission Street** on a report of a male and female arguing, and that the male subject attempted to keep the female in his white Toyota Camry. Officer Todaro asked the male subject to step out of the vehicle, and the subject complied. Officer Todaro patted down the male and found a handle of a handgun sticking out of the waistband of his pants. The gun was a loaded 9 mm Smith and Wesson. The subject also had a plastic baggie with a substance believed to be methamphetamine. The officer placed the subject, a 37-year old San Francisco resident, under arrest for possession of a controlled substance while armed, carrying a loaded firearm in a public place, false imprisonment, and for possession of unlawful paraphernalia. The female, an 18-year old Reno resident, was unharmed.

On Saturday, 09-28-19 at approximately 12:39 a.m., a 36-year old Daly City resident was arrested for driving under the influence of alcohol and for driving under the influence with a BAC of 0.08% or higher after he was involved in a collision on the unit block of **Garibaldi Street**.

On Sunday, 09-29-19 at 2:44 a.m., subsequent to a traffic stop by **Officer Fulmore** at the corner of **Menlo Avenue** and **Skyline Drive**, a 37-year old Daly City resident was arrested for transportation of a controlled substance for sales, possession of a controlled substance for sales, possession of drug paraphernalia, possession of a controlled substance, and delaying a peace officer in the performance of his/her duties.

Robberies

There were three robberies during the past week.

On Wednesday, 09-25-19 at 10:53 a.m., the **U.S. Bank** on **Gellert Boulevard** was robbed by a subject wearing a wig who passed a note and left in a silver Nissan Sentra after getting the money. Our alert **Detective Clinkscales** advised that he was traveling behind the suspect vehicle, and with the help of additional officers, the subject was taken into custody. After the bank employee positively identified the subject, officers placed the subject, a 49-year old Tarzana resident, under arrest for robbery. The subject gave a full confession and also confessed to another robbery in Millbrae.

On Wednesday, 09-25-19 at 1:20 p.m., **Officer Farrar** was dispatched to the unit block of **Park Plaza Drive** a report of a strong-arm robbery. The victim, a 28-year old Daly City resident, said she was walking between buildings on the 100 block of Park Plaza Drive when a subject on a bicycle rode up behind her on a mountain bike and took her cell phone (iPhone 6 plus) from her left rear pants pocket. The victim described the subject as a black male, 25-30 years old, 6'-0" with a slender build, wearing all black clothing and riding a dark colored bicycle with a red front rim.

On Friday, 09-27-19 at 4:40 p.m., **Officer Gill** was dispatched to the area of **Dim Sum King Chinese Restaurant** at **Skyline Plaza** on a report of a just-occurred robbery. The victim, a 77-year old Daly City resident, said she had just concluded a bank transaction at the **East West** bank when she was returning to her vehicle. The victim said as she sat down, she went to put her purse on the front passenger seat, and she felt someone try to tug her driver's door open with her hand still on the handle. The victim said she quickly shut the door and locked it, and she heard several loud "bangs" followed by one louder "bang" and the sound of glass shattering. The victim said she used her hands to cover her face and neck because she thought someone was shooting into her vehicle. The victim said as she did this, she saw a male figure reach into the shattered rear driver's side window and take her Coach purse from the front passenger seat. The victim could not identify the suspect, but this investigation is continuing.
