When I mention "the unit block" of a street, this means the incident occurred at an address anywhere between 1 and 99 of the street.

Notable Cases

On Monday, 02-13-17 at 3:29 p.m., Officer Wagnon conducted a traffic enforcement stop on a vehicle at the intersection of **Geneva Avenue** and **Calgary Street**. The driver, a 31-year old Daly City resident, had a large amount of cocaine in his possession and was arrested for possession of cocaine for sales, as well as for committing a felony while out on bail.

On Friday, 02-17-17 at 3:46 p.m., Officer Clinkscales was on patrol in the **Westlake** area and saw a subject who was riding a bicycle and was carrying multiple bags, struggling to control his bicycle. Officer Clinkscales asked the subject if he was okay to ride the bicycle without falling, and the subject stated he was. The officer asked the subject if he was on probation, and the subject replied, "I think I am." The officer asked if he had any weapons, drugs or pipes in his possession, and the subject said he had a pipe but that he found it picking up garbage. The subject admitted to using methamphetamine the day before and that he had a pipe, as well as a usable quantity of methamphetamine in his possession. The officer cited the subject, a 64-year old Pacifica resident, for possession of a controlled substance and for possession of drug paraphernalia.

On Saturday, 02-18-17 at 5:35 p.m., Officer Murillo was on patrol in the area of Serramonte Shopping Center near Target due to rash of recent auto burglaries. Officer conducted a traffic stop on a vehicle containing three subjects in the area of **Serramonte Boulevard** and **Gellert Boulevard**. The officer asked the subjects to exit the vehicle one at a time, and when the officer asked one passenger if he had any guns, knives or drugs in his pockets, the passenger admitted to having a ".22" in his pocket. The officer analyzed the firearm, a .22 long revolver firearm, and saw there were six rounds in the cylinder, and the hammer was cocked back and ready to fire. The subject, a 19-year old San Francisco resident, was arrested for being in possession of a concealed/loaded firearm not being the registered owner, and for carrying a loaded firearm in a public place.

On Sunday, 02-19-17 at 12:23 a.m., subsequent to a traffic stop by Officer Soyangco in the area of **Mission Street** and **Vista Grande Avenue**, a 23-year old San Francisco resident was arrested for possession of a controlled substance (rock cocaine) for sales.

On Sunday, 02-19-17 at 9:11 p.m., Officer McQuade and Officer Soyangco conducted a traffic stop on a vehicle at **Mission Street** and **Vista Grande Avenue**. The officers smelled a strong odor of alcohol in the vehicle. Following their investigation, the officers arrested two subjects. One subject, a 21-year old San Francisco resident, was arrested for possession of a controlled substance (methamphetamine) for sales, transportation of a controlled substance for sales and for possession of a narcotic substance. The other subject, a 24-year old Daly City resident, was arrested for possession of a controlled substance (methamphetamine).

Robberies

There were two robberies during the past week.

On Tuesday, 02-14-17 at 10:10 a.m., a 28-year old Daly City resident was the victim of a strong armed robbery by a 17-year old Pacifica resident. The victim said he was walking by himself to his apartment on the 500 block of **Clarinada Avenue**, and he noticed a subject in the hallway outside of an apartment. He said there were a group of males in female outside of an apartment, and he saw the one particular subject smashing the hallway windows with his hands. The victim continued to walk to his apartment and said the subject pushed him from behind, causing him to fall in the hallway. The victim dropped his keys and said the subject picked up his car key and fled. The victim said the subject then tore out a fire extinguisher from the hallway wall and used it to batter apartment doors and windows and caused damaged to both. Officers arrived and ultimately arrested the subject for robbery, threatening police officers, vandalism and for an outstanding warrant.

On Friday, 02-17-17 at approximately 5:53 p.m., a 46-year old San Francisco resident was the victim of a strong armed robbery by three unknown male subjects who used a handgun to strike him on the head and nose, causing him to lose consciousness. This occurred in the area of **Villa Street** and **Hoffman Street**. The victim said the suspect took his wallet containing his identification and cash. The victim was treated at San Francisco General Hospital. This investigation is continuing.

Residential Burglaries

There were no residential burglaries during the past week.

Commercial Burglaries

There was one commercial burglary during the past week.

On Sunday, 02-19-17 between 5:30 p.m. and 7:30 p.m., an unknown suspect pried open the lock to a locker in the women's locker room of **Crunch Fitness** and stole an Under Armor gym bag containing clothing, a wallet and debit cards. The debit cards were used at nearby businesses.

Vehicle Burglaries

There were eight vehicle burglaries during the past week. All of them occurred in parking lots, and all of the victims left their property in plain view.

Scams/Other

I.R.S. Tax Scam

Since tax season is fast approaching, I just wanted to advise you that scam artists may be getting ready to begin their quest to scam innocent people out of their money. These scam artists call unsuspecting people and identify themselves as representatives from the I.R.S. Typically, they tell the victims that they owe money for prior tax years and must pay immediately or risk being arrested. The callers are convincing, and they prey upon people's vulnerabilities, and oftentimes they are successful. They instruct the victims to obtain pre-loaded cards from convenience stores, and then the request the victim to give the codes from the card to make the payment. I just want to remind you that the I.R.S.

will NEVER demand payment without first sending a notification via mail. Furthermore, they would NEVER demand payment in the form of a pre-loaded debit card. If you are in doubt, please visit the I.R.S. website at https://www.irs.gov/ for information. I will leave this posting up for at least the next month. Please share this information with your friends, family and co-workers. I hope this season that no one falls prey to these scammers. There was a big arrest in India a few months ago, and perhaps that curbed the scammers, but it's always good to be aware.

Community Events/Information

Medication Disposal Kiosk at City Hall

The City of Daly City has partnered with MED-Project (http://www.med-project.org/) to offer a free, safe, and convenient location for residents to dispose of unwanted or expired medication from households by way of the San Mateo County Safe Medicine Disposal Ordinance. San Mateo County entered an agreement with MED-Project LLC to provide kiosks throughout the County for disposal of household pharmaceutical products.

A Med-Project secured kiosk is now located outside the Daly City Police Department in the City Hall rotunda at 333-90th Street. Drop-offs can be made in the lobby during regular business hours (M-F: 8:00 am to 6:00 pm, Saturday: 8:00 am to 12:00 pm). The MED-Project is in the process of updating kiosk locations in San Mateo County on their website.

The kiosk accepts medications in any dosage form in their original container or sealed bag. No herbal remedies, vitamins, supplements, cosmetics or other personal care products; compressed cylinders, aerosols, and inhalers; medical devices; sharps; illicit drugs; or iodine-containing medications will be accepted.

MED-Project is a pharmaceutical product stewardship organization that is financed by the pharmaceutical producers operating in several jurisdictions. The mission of MED-Project is to implement an accessible, convenient, and comprehensive program for the collection of household generated pharmaceutical waste.

Free Household Hazardous Waste Disposal—Saturday, March 11th, 8:30 a.m. 12:00 p.m.

Do you have any household cleaning products, paints, paint thinners, fluorescent lights, photo chemicals, inks, used motor oil and oil filters, batteries, fertilizers, pesticides you need to dispose? These products are often labeled as toxic, poisonous, combustible, corrosive, flammable or irritant. Daly City residents can safely dispose of these items free of charge at a special drop-off collection event on Saturday, March 11th between 8:30 a.m. and 12:00 p.m. To participate, residents **must** schedule an appointment at San Mateo County's Household Hazardous Waste (HHW) program: www.smchealth.org/hhw or by calling (650) 363-4718 and selecting option 3. There is a restriction of 10 gallons or 50 pounds per appointment based on transportation regulations. It is unlawful to dispose many types of common household waste into landfill-bound residential and commercial garbage receptacles.

If you have any unwanted latex paint, you may be able to bring it to a paint retailer in Daly City. Visit http://www.paintcare.org/paintcare-states/california/ to find a latex paint drop-off center near you. PaintCare is an industry-sponsored paint stewardship non-profit program established to manage the reuse, recycling and proper disposal of unused architectural paint.
