When I mention “the unit block” of a street, this means the incident occurred at an address anywhere between 1 and 99 of the street.

Notable Cases

On Monday, 11-21-16 at 9:21 p.m., a 45-year old Daly City resident falsely reported that his girlfriend’s 19-year old son brandished a knife. The subject dialed 911 to make the report, and numerous officers responded to the emergency call at a residence on the 800 block of **Schwerin Street**. After officers determined this crime did not occur and when the subject admitted to falsely making a report, they arrested the subject for reporting a false emergency to the police.

On Thursday, 11-24-16 at 4:00 p.m., Officer Philip Wagnon was dispatched to the Walgreens on **Mission Street** on a report of a customer who climbed onto the roof and was stating he was an escaped prisoner and that people were after him. The officer contacted the subject who agreed to climb down safely using the fire escape. The officer saw that the subject was sweating heavily and had a rapid pulse. He asked the subject if he was high on methamphetamine, and the subject said he was. The officer saw that the subject was wearing an ankle bracelet and asked him about it. The subject said he was released from prison a couple of days before and told the officer he just used a “speedball” a few hours prior. The subject agreed to participate in a sobriety test, and after conducting the test, Officer Wagnon determined the subject was under the influence of a controlled substance. The subject, a 36-year old San Francisco resident, said after he injected a “speedball”, he had not slept since. He said he climbed on top of the roof because he thought former gang members were following and chasing him. The subject was arrested for being under the influence of a controlled substance.

On Saturday, 11-26-16 at 2:06 p.m., Officer Alex Murillo attempted to stop a vehicle at the intersection of **Serramonte Shopping Center** and **Southgate Avenue**. The driver of the vehicle refused to yield to the officer until he reached area of the Flyers gas station on Junipero Serra Boulevard. The occupants all fled from the vehicle but were all caught nearby after they scattered in different directions. The dispatchers advised the vehicle was reported stolen from San Jose. The driver, a 22-year old Stockton resident, was arrested for felony evading, vehicle theft, possession of a stolen vehicle, resisting arrest, misdemeanor hit and run and reckless driving. The front passenger, a 25-year old Yuba City resident, was arrested for obstructing/resisting a peace officer. A rear passenger, a 23-year old Stockton

resident, was arrested for obstructing/resisting a peace officer. The other rear passenger, a 27-year old Oakland residence was arrested for obstructing/resisting a peace officer and for a parole violation.

Robberies

There was one robbery during the past week.

On Friday, 11-25-16 at 5:02 p.m., an asset protection agent at **Home Depot** reported he saw a subject who stole items and walked out of the store without paying. The agent told the suspect to return the property and come back inside the store. The agent said the subject dropped a grinder he was carrying and began to run away from the store. The agent said he grabbed ahold of the subject who was struggling to get away with the tool bag full of merchandise he was carrying. In the scuffle, the loss prevention agent suffered a scratch to his forehead. Another loss prevention officer assisted in detaining the suspect until police arrived. The subject, a 22-year old transient, provided false identifying information to the police officer and also had a Visa debit card not belonging to him in his possession. The subject was arrested for robbery, burglary, providing false information and misappropriation of lost property.

Residential Burglaries

There was one attempted residential burglary during the past week.

On Wednesday, 11-23-16 at approximately 8:17 p.m., a residence on the 800 block of **St. Francis Boulevard** was the victim of an attempted residential burglary. An unknown suspect kicked in the rear door to a storage basement and was scared off after an audible burglar alarm sounded. No entry was made.

Commercial Burglaries

Scams/Other

On Tuesday, 11-22-16 at 3:39 p.m., a 35-year old San Francisco resident reported that she was the victim of a Craigslist scam. The victim said she saw an ad to rent a home for \$1,265. The victim sent an email stating she was interested in renting the residence, and she said she received an email in return in which the sender provided her with a CitiBank account number. The sender advised the victim to deposit \$1,265 into the account. The victim deposited the money as requested, but she never received a confirmation email or notification. The victim sent an email to the subject "calling him out" on the fraud, and the victim said the suspect denied the fraud and stated, "Sorry, there was an emergency." This case is still an open investigation.

Community Events/Information

Household Hazardous Waste Disposal Event—Saturday, December 10, 2016

San Mateo County residents can safely dispose of household hazardous waste (HHW) free of charge on Saturday, December 10 from 8:30 a.m. to 12:15 p.m. only by appointment. Residents are required to schedule an appointment at San Mateo County's HHW program on line at www.smchealth.org/hhw or by phone at (650) 363-4718 and select option 3. You will be given the drop off location after you make your appointment.

Accepted items include acids/bases, aerosol cans, automotive supplies (car batteries, motor oil, antifreeze, brake fluid), cleaning products, fertilizers, pesticides, flammable liquids, fluorescent lights (compact and tubes), paint, inks, and photo chemicals. No radioactive, explosive, medical or commercial waste is allowed. All waste collected is reused, recycled, or stabilized for proper disposal to achieve zero waste being landfilled.

This private network ensures that only those who live in your neighborhood can join; users must go through a verification process. Neighbors ask each other for business recommendations; help in locating missing pets; discuss relevant local government issues; or connect for other reasons.
