Note: It was brought to my attention that when I mention "the unit block" of a street, some people might now know what this means. In case you are interested, this means the incident occurred at an address anywhere between 1 and 99 of the street.

Notable Cases

On Monday, 10-27-14 at 3:30 p.m., a Home Depot store clerk was the victim of a robbery by a suspect who took a power drill and walked out of the store without paying for it. The victim, a loss prevention officer, grabbed the suspect outside of the store, but the suspect pushed him aside and fled to a vehicle and drove away. The victim was able to get the license plate of the vehicle, and officers attempted to find the vehicle but were unsuccessful. Officers were able to determine the identity of the suspect based on the license plate. Detectives arrested the suspect, a 21-year old Daly City resident, for the following day for burglary and petty theft with a prior jail term. The victim was unharmed.

On Tuesday, 10-28-14 at 11:08 hours, Officer Joshua Moala checked on an illegally parked vehicle at the Thornton Beach Vista parking lot. Officer Moala smelled a strong odor of burnt marijuana emanating from the vehicle and noticed a plastic cylinder container containing a green leafy substance, suspected to be marijuana, in the vehicle. The officer asked the driver if he had a medical marijuana card, and he said he did, but it was expired. After the driver consented to the officer searching his vehicle, the officer found inside a plastic case a plastic baggie containing a white powdery substance believe to be cocaine. He also found other narcotics paraphernalia in the vehicle. The driver, a 20-year old San Bruno resident, was arrested for possession of a controlled substance and possession of narcotics paraphernalia.

On Thursday, 10-23-14 and Thursday, 10-30-14, based upon several tips, the Daly City Police Department completed two separate undercover operations for prostitution (illegal sex acts) at the Union Spa & Salon at 7345 Mission Street and at SH Body Therapy at 333 Gellert Boulevard #122. In each case, a massage parlor employee solicited an undercover officer for sex acts. A 51-year old Sacramento resident was arrested in the first case, and a 57-year old San Francisco resident was arrested in the second case. Both of these cases have been turned over to the San

Mateo County District Attorney's Office for prosecution, as well as the Office of the City Attorney for the city of Daly City for possible administrative action.

On Sunday, 11-02-14 at 6:26 p.m., Officer Christopher Collins and Officer Kelly Lemere were dispatched to the Westlake Nail Spa at the Westlake Shopping Center on a report of three intoxicated males harassing customers. Officers found two subjects who said the other subject left on foot. Officer Lemere conducted a records check on both subjects and found one subject had firearms registered to him. Officer Lemere asked the subject if he had anything illegal on his person, and he admitted to having a knife, a baton and pepper spray. The second subject had nothing illegal upon his person. The first subject, a 49-year old Berkeley resident, was arrested for possessing all three items.

Robberies

There was one attempted robbery during the past week.

On Tuesday, 10-28-14 at 9:15 p.m., officers were dispatched to the 300 block of Crocker Avenue on a report of a subject trying to get into a victim's vehicle. The victim, 46-year old Daly City resident, said she was attempting to park her vehicle in front of her residence when she said a Hispanic male subject carrying a water bottle in his hand and spraying water out of his mouth was standing in front of her vehicle. The victim said she was concerned for her safety and locked all the doors to her vehicle. She said the subject then tried to open the passenger side door but was unable to get into her vehicle because the door was locked. The victim said she called to her boyfriend inside of the residence to help, and he came out with a crowbar, dragging it on the ground to alert the suspect. The suspect walked away, and the victim's boyfriend followed. The victim drove her vehicle to pick up her boyfriend when the subject tried again to open the car door. Officers found the subject and determined he was under the influence of a controlled substance. He was arrested for being under the influence, as well as for attempted carjacking.
