



## Crime Alert and Community Update Bulletin

Note: It was brought to my attention that when I mention “the unit block” of a street, some people might now know what this means. In case you are interested, this means the incident occurred at an address anywhere between 1 and 99 of the street.

### Notable Cases

On Thursday, 10-23-14 at 2:59 a.m., Officer Kenneth Kim conducted a traffic stop near Hillside Boulevard and Tallwood Drive for a vehicle code violation. The driver, a 27-year old Daly City resident, was on probation. Because the driver was on probation, he was subject to a probation search. Several officers arrived at the scene, and the driver took them to his house, which was up the street on Tallwood Drive, and he consented to a search of his room. Officers found a bag of marijuana, a scale, baggies, a box with several pills, two bags of an unknown white powdery substance (believed to be MDMA), and a large roll of cash. The subject was then arrested for possession of marijuana for sales, selling marijuana, and possession of controlled substances.

On Thursday, 10-23-14 at 4:43 a.m., Officer Isaako Poti and Officer Ben Wagnon saw a subject with an unsteady gait crossing East Market Street near 2<sup>nd</sup> Avenue. When officers made contact with the subject, they noticed he had slurred speech, bloodshot eyes and they smelled a strong odor of alcohol emanating from him. They also noted he was speaking very rapidly. The subject admitted to “drinking a lot at a bar in San Francisco earlier”, and the officers asked if they could search him. The subject consented, and the officers found a baggie containing a white powdery and rock substance in the subject’s pants pocket. They found a plastic sandwich bag containing marijuana in his back pocket, as well as an identification card not belonging to him in the other back pocket. Officers arrested the subject, a 27-year old Daly City resident, for possession of cocaine base, identity theft, false impersonation, and for possession of marijuana.

On Thursday, 10-23-14 at 2:20 p.m., officers conducted an undercover investigation at the “Union Spa & Salon” on Mission Street after receiving several anonymous tips about illegal prostitution occurring at the spa. The masseuse, a 51-year old Sacramento resident, was arrested for prostitution after soliciting an act of prostitution from the undercover officer.

A 63-year old Daly City resident reported that she was bilked out of her 2013 Federal and State Income Tax refund totaling \$26,873 from a free-lance tax preparer who was recommended to her by a family friend. The victim said she attempted to contact the tax preparer on numerous occasions, but her calls went unanswered. The investigation involved both the Internal Revenue Service and a large banking institution who provided detectives with enough probable cause to find and arrest the suspect. The tax preparer switched the address for the return check, and the tax preparer deposited the check into his own account. On Thursday, 10-23-14, detectives tracked the suspect, Brian Jeffers, a 43-year old Half Moon Bay resident, at his place of employment and arrested him without incident.

On Thursday, 10-23-14 at 11:30 p.m., a resident on the 500 block of South Hill Boulevard reported his Ford F150 pick-up was stolen from in front of his residence. This area has recently been plagued with auto thefts. Officer Wailun Shiu conducted a neighborhood check and met with a neighbor who provided video surveillance information from the exterior of his residence. Officer Shiu saw a female exit the truck and sit on the stairs of a residence on Alta Vista Way. The female was extremely nervous and was shaking while making spontaneous statements about the vehicle and the passenger. With the assistance of a K-9, officers found another female hiding underneath the stairs of a residence on Alta Vista Way. After an investigation, the first subject, a 32-year old San Francisco resident, was arrested for possession of a stolen vehicle, criminal conspiracy and for possession of drug paraphernalia. The second subject, a 22-year old transient, was arrested for possession of a stolen vehicle, criminal conspiracy, possession of altered keys and for two bench warrants.

On Thursday, 10-23-14 at 6:38 p.m., Officer Nick Ottoboni and Officer Dante Digiacommo were dispatched to the 300 block of Otilia Street on a report of an unknown woman sitting in the reporting party's vehicle. The reporting party said his wife alerted him to the woman in the vehicle, and he began videotaping the suspect. While Officer Ottoboni was speaking with the reporting party, a witness flagged him down saying there was a woman attempting to break into cars on Accacia Street. The woman was the same one who was in the reporting party's vehicle. Officers arrested the suspect, a 48-year old San Francisco resident, for auto burglary and petty theft with a prior jail term.

On Saturday, 10-25-14 at 9:13 a.m., Officer Dave Uziel stopped a vehicle for a stop sign violation at King Drive at Callan Boulevard. The driver told the officer that he was very sick and needed to get home quickly. The officer asked the subject if he could search his person and his vehicle, and the subject complied. The officer found a bag containing unused hypodermic needles and other items used by heroin users. The subject, a 23-year old Pittsburg resident, admitted to using heroin and said he was trying to quit—which was why he wasn't feeling well. Also in the vehicle was a gold necklace. The subject admitted to taking the necklace from his parent's house so that he could pawn it for drugs. The subject was placed under arrest for residential burglary, driving under the influence of a controlled substance, being under the influence of a controlled substance and for possession of paraphernalia for controlled substances.

On Sunday, 10-26-14 at 11:11 a.m., Officer Christopher Collins and Officer Dave Uziel were dispatched to the 500 block of San Diego Avenue on a report of a male subject on a person's roof who was yelling. When the officers arrived on scene, they saw the subject and told him to stay where he was and not to jump. At that time, the subject jumped from the roof and landed on his feet. He didn't appear to be injured from the jump, but he had sustained a severe cut to his left arm from smashing a window of a house. An ambulance transported the subject, a 40-year old Belmont resident, to San Francisco General Hospital for treatment to his arm and then placed on a hold for being a danger to himself.

There were nine arrests for driving under the influence this past week.

## Robberies

There was one attempted robbery during the past week.

On Thursday, 10-23-14 at 7:17 p.m., an unknown subject attempted to steal merchandise from the Dollar Store on Geneva Avenue and slapped the store clerk in the face twice with her hands before leaving the store. The victim said she recognized the suspect from a previous theft, and she observed the suspect attempting to walk out of the store without paying for the two baskets of merchandise. The victim said she was hit when she stood in front of the doors. The then suspect dropped the merchandise and left on foot westbound on Geneva Avenue towards Accacia Street. The victim had no visible injuries. The suspect is described as a black female adult, 40 years old, black hair in a bun, brown eyes, heavy build, wearing a black shirt and floral leggings that were pink and orange.

- 200 block of Rio Verde Street—attempted burglary only to a 2005 Toyota Tacoma. The rear passenger window was damaged. Occurred between 2:00 a.m. on 10-22-14 and 8:00 a.m. on 10-23-14.
