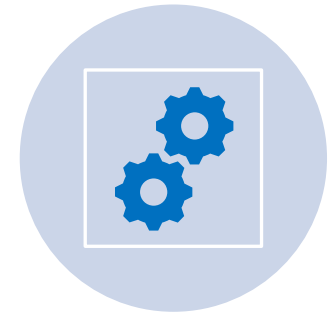

# Cannabis Equity Assessment

**Purpose:** Analysis of the historical impacts of cannabis-related policies and enforcement on communities and populations within the City of Daly City.

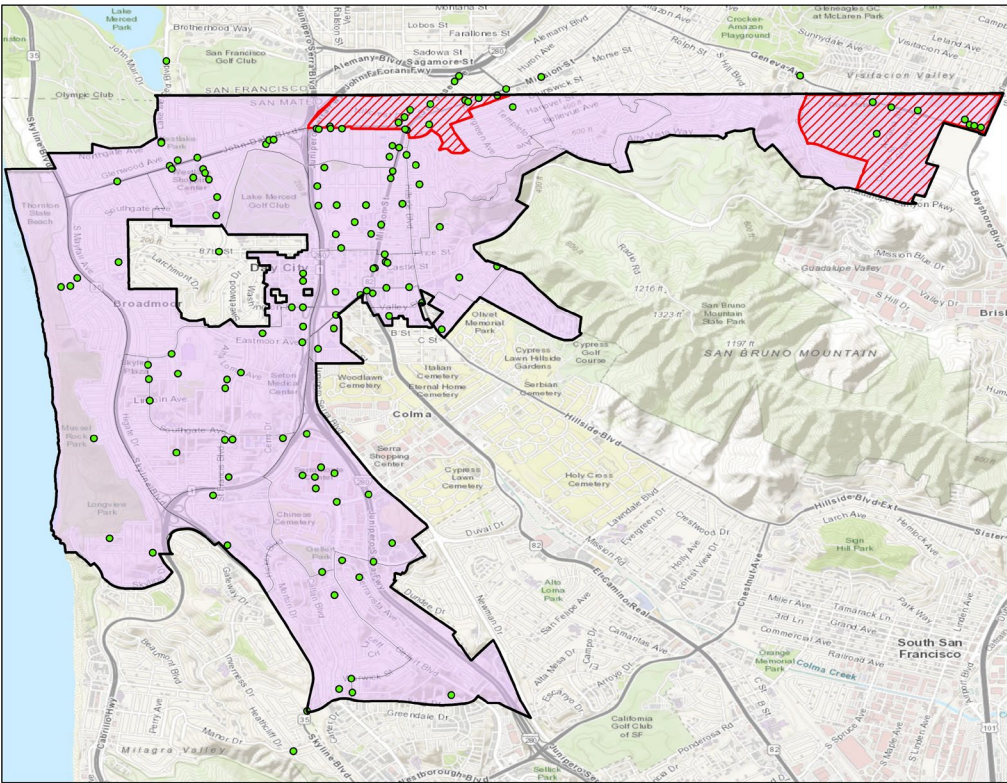
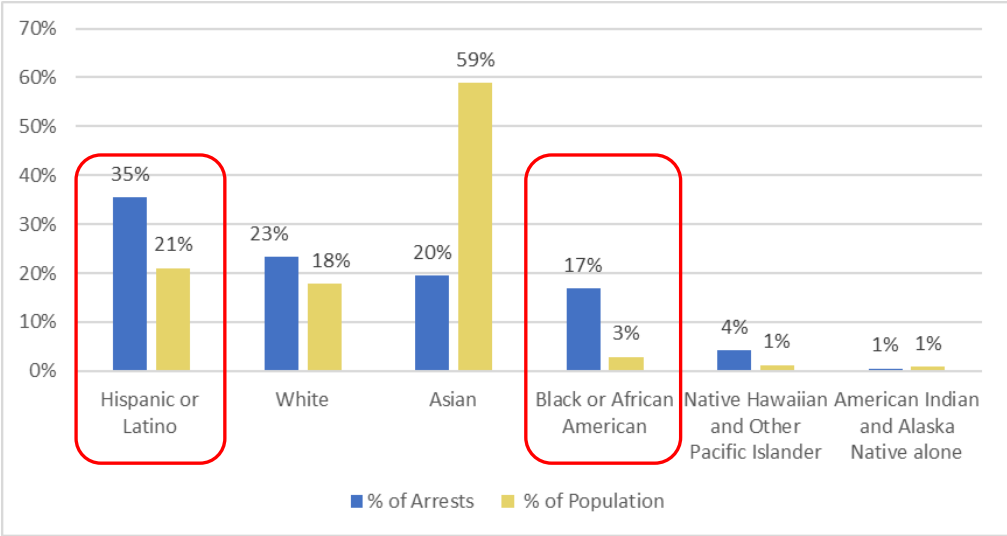
- Data-informed look at the history of impacts the illegalization
  - Analysis of Police statistics, demographics, poverty, and unemployment
- Identify, confirm, and describe impacted communities and populations
- Discuss barriers to entry
- Provide policy recommendations for program development:
  - Program Eligibility, Program Benefits/Services, Regulatory Changes





# Equity Analysis – Key Findings

- 200 cannabis-related arrests (2009-2024)
- Black & Hispanic/Latino populations disproportionately arrested
- Most impacted neighborhoods: Mission Street/Crocker Ave and Bayshore





# Summary of Stakeholder Outreach

---

## ➤ Key Takeaways:

- Barriers to Entry & Financial Challenges
- Smoke Shops & Illicit Market Competition
- Oversaturation of Retail Licenses
- Land Use & Zoning Restrictions

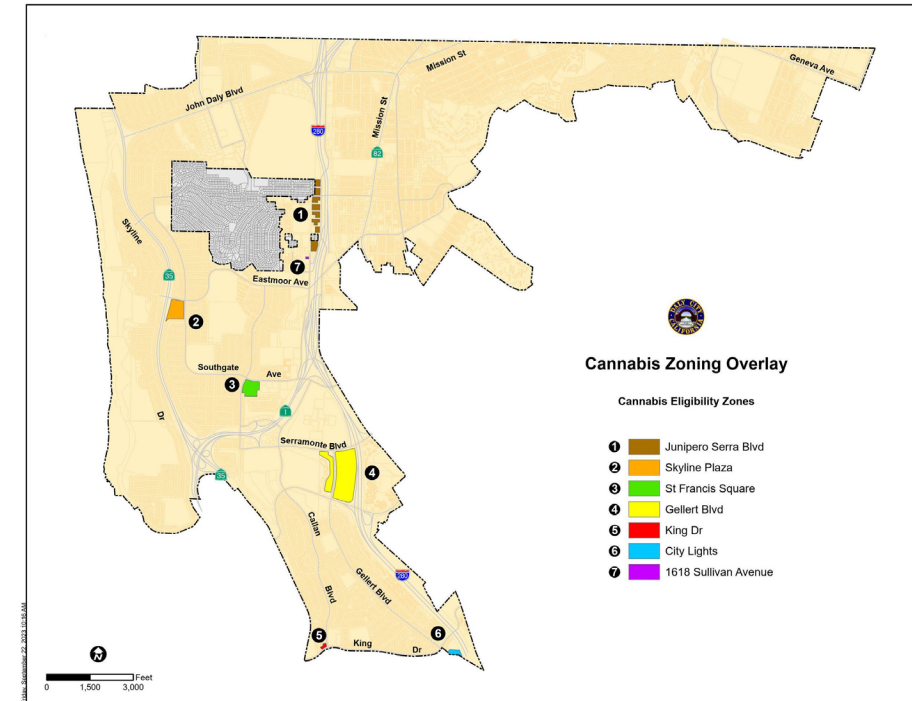
## ➤ Stakeholders suggest:

- Stronger enforcement against unlicensed shops.
- Balanced retail licensing to avoid oversaturation.
- Landlord incentives to lease to equity applicants.
- Zoning reforms for more equitable access to property.



# Cannabis Regulatory Landscape in Daly City

- City approved legalized Commercial Cannabis Activities in 2021
  - Chapter 5.104 (Commercial Cannabis Regulations)
  - Chapter 17.56 (Cannabis Combining District Zoning Overlay)
- **Allowed Uses:**
  - Cannabis Retailers and Testing Laboratories
  - Retail capped at 7 businesses – one within each of the seven cannabis eligibility zones
- **Retail Licenses:**
  - Four licenses issued for Zones 1,2,5 and 7
  - Two are currently operational in Zones 1 and 5
  - Three are left in Zones 3, 4 and 6
- Lottery Selection process to award retail licenses





# Expanding Equity Opportunities in Daly City

## ➤ Open New Equity Eligibility Zones

- Add two (2) new Eligibility Zones in historically impacted areas (Bayshore & Mission Street)

## ➤ Equity Retail Licenses

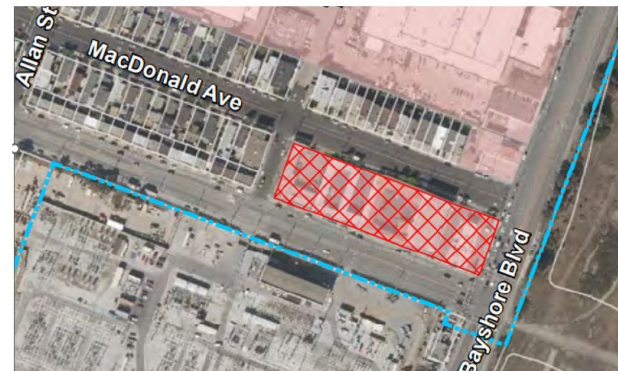
- Reserve remaining retail licenses for Equity

## ➤ Potential New Cannabis Use Types

- Distribution
- Microbusiness (Retail, Distribution, Non-Volatile manufacturing)
- Non-Storefront Retail



AREA B (Geneva Avenue between Talbert Street and Bayshore Boulevard)



AREA C (Geneva Avenue between Castillo Street and Calgary Street)







# Proposed Eligibility Criteria

---

➤ *To qualify as an Equity Applicant, individuals must meet all of the following:*

- **Justice Impact:**

- Arrest or conviction for a cannabis offense (or an immediate family member) in California or United States prior to November 8, 2016

- **Income & Asset Limits:**

- Household income below 80% of the Area Median Income (San Mateo County) OR eligible for public assistance (e.g., CalFresh, Medi-Cal, CalWORKS, SSI, SSDI) AND a net worth under \$250,000

- **Residency Bonus:**

- Residency requirement is built into the lottery - Applicants who meet this get more entries

## ➤ Technical Assistance

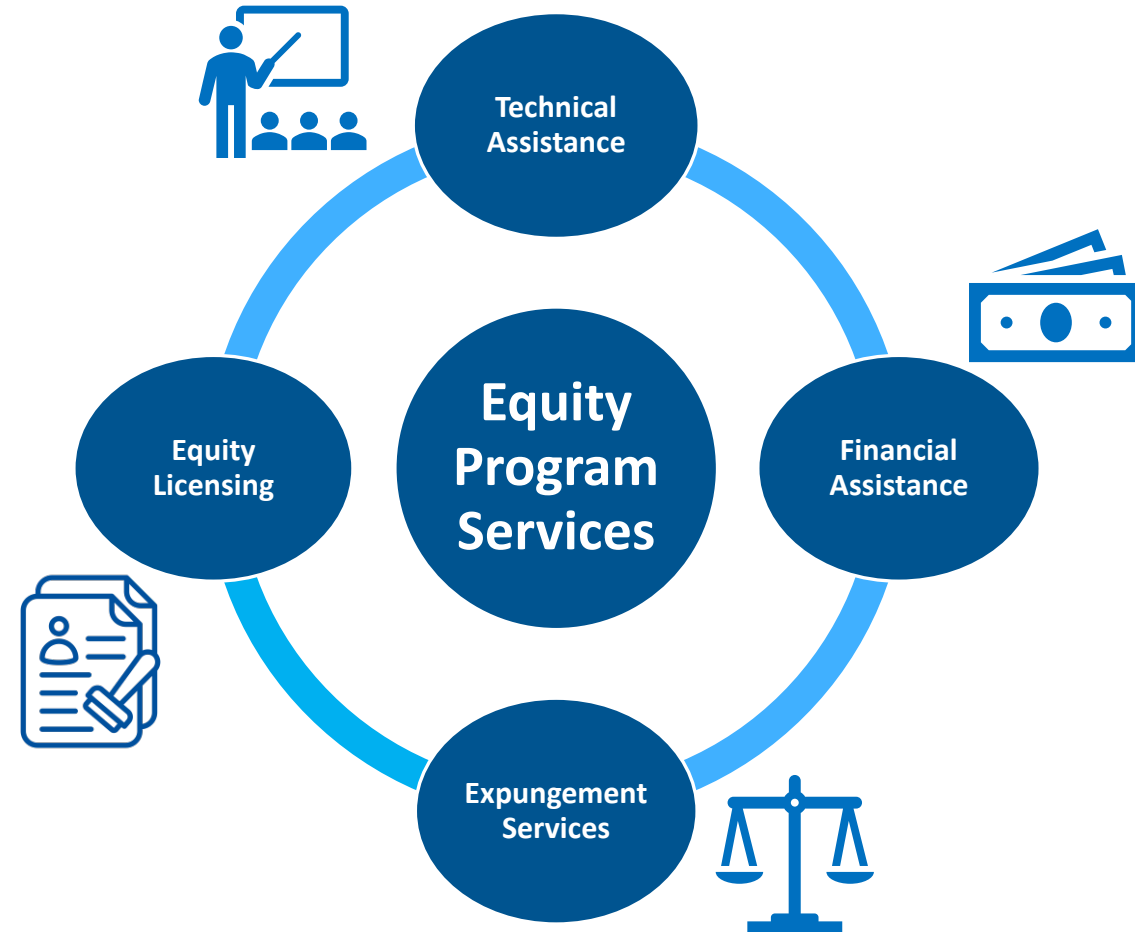
- Cannabis Certification & Business Development Courses
- Application Assistance and Workshops

## ➤ Financial Assistance

- Fee waivers
- Direct Grants (depending on availability of State Grant funding)

## ➤ Equity Licensing

## ➤ Expungement Services
