**NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT**  
**ON THE DRAFT APPLICATION FOR SECTION 108 LOAN FUNDS TO**  
**FINANCE AN EARLY LEARNING CENTER**

NOTICE IS HEREBY GIVEN the City of Daly City has prepared a Draft Application for Section 108 Loan Funds. Loan funds will be used for the development and construction of a new 6,800 square foot Early Learning Center to be located at the northeast corner of Sullivan Avenue and 92<sup>nd</sup> Street (1401 Sullivan Avenue). The application describes the early learning center project in detail, total development budget, development schedule, and how the new center will meet National Objectives and the childcare needs of Daly City families. The Center will be comprised of four classrooms, outdoor play areas as well as teacher support and restrooms. In total, the Center will serve 42 infants and toddlers with no fewer than 51 percent from lower income households. The total amount of the proposed loan will be \$3.2 million dollars and will be repaid using annual allocations from the City's Community Development Block Grant.

The Draft Section 108 Loan Application is available for public review and comment beginning Sunday, May 25, 2025 through Monday, June 9, 2025. In the body of the email, include the item number and/or title of the item as well as your comments. All comments received by 4:00 pm will be emailed to the City Council members prior to the meeting. Those comments received after 4:00 pm will be added to the record and shared with the City Council members following the public meeting. Comments are not read aloud into the record.
