

PUBLIC NOTICE
UNIFORM CONSTRUCTION COST ACCOUNTING ACT NOTIFICATION

The City of Daly City, California adopted Resolution No. 11-66 on May 23, 2011, approving the City electing to become subject to the Uniform Public Construction Cost Accounting Act. These informal bidding procedures allow Public Works construction projects, as defined in the California Public Contract Code (PCC), meeting specific criteria for cost (currently less than \$220,000) to be performed by the contract acquired by informal bidding procedures.

The City of Daly City is seeking to establish a list of “qualified bidders” as specified under the Uniform Construction Cost Accounting Act. Per the PCC Section 22036, the City of Daly City hereby provides public notice and solicits licensed contractor interest in placement on the City of Daly City’s Bidders List.

In order to be included on the City of Daly City’s Bidder List, interested and licensed contractors must provide the name and address to which a Notice of Contractors or Proposal should be mailed, a phone number at which the contractor may be reached, the type of work in which the contractor is interested and currently licensed to perform (earthwork, pipelines, electrical, painting, general building, general engineering, etc.) together with the class(s) of contractor’s license(s) held and the contractor’s license number(s). All interested contractors should fill out the required information on the Contractor’s Pre-Qualification Application (see attachment) and mail or fax to:
