When I mention “the unit block” of a street, this means the incident occurred at an address anywhere between 1 and 99 of the street.

Robberies

There was one robbery during the past week.

On Friday, 06-09-23, at approximately 7:17 p.m., officers were dispatched to **Nordstrom Rack** on a report of a subject who took shoes. A loss prevention agent stated that the suspect selected a pair of white shoes worth approximately \$55 and put it on. The subject walked around the store and went to pay for a bottle of cologne but made no attempt to purchase the shoes he was wearing. After the suspect exited the store with unpaid merchandise, the loss prevention agent said that she needed to speak with the suspect about the unpaid merchandise that he was in possession of. The suspect handed the loss prevention agent a bag of unpaid merchandise but refused to enter the store with the loss prevention agent. The suspect pushed the loss prevention agent and fled on foot. Officers found the suspect hiding behind bushes, and a bag of methamphetamine was located around where the suspect was hiding. The suspect, a 34-year-old Burlingame resident, was arrested and booked into jail for robbery, possession of a controlled substance, and an outstanding warrant.

Residential Burglaries

There was one residential burglary during the past week.

On Saturday, 06-10-23, at approximately 1:18 p.m., a residence on the 800 block of **Campus Drive** was a victim of a residential burglary. Unknown suspect(s) broke the front door lock. It is unknown if anything was stolen.

Commercial Burglaries

There were two commercial burglaries and one attempted commercial burglary during the past week.

On Monday, 06-05-23, between 1:00 p.m. and 2:00 p.m., at the 300 block of **Palmcrest Drive**, suspect(s) stole Michael Kors bags, Nike shoes, collectible ornaments, clothing, an Xbox game console, and Legos, all valued at approximately \$6,200, from a storage unit. **Online report.

On Saturday, 06-10-23, at approximately 7:15 p.m., officers were dispatched to **Smart & Final** on **Mission Street** on a report of a commercial burglary. An employee stated that she saw two suspects walk into Smart & Final. One of the suspects stood next to a cash register, removed \$300, and then left the store. The second suspect left the store shortly after. The suspect who removed the cash from the register was described as a Black male, approximately 50 years old, bald with a white beard, wearing a camouflage hoodie, blue jeans, and white shoes. The second suspect was described as a Black male, approximately 25-35 years old, wearing glasses, a hat, and a grey vest with long black sleeves and a red flame design across the front.

On Tuesday, 06-06-23, at approximately 2:05 p.m., **McDonald's on Geneva Avenue** was a victim of attempted commercial burglary and vandalism. A suspect entered the restaurant and tried to pry open a donation box. After being unable to pry open the donation box, the suspect grabbed a register and began to pull at it. After noticing that there was no cash in the register, the suspect broke a Plexiglas shield off the counter and walked toward the exit. The suspect proceeded to push a double trash can container off the wall and again removed a Plexiglas shield off the counter. The suspect grabbed ketchup packages and threw them at employees. The suspect was described as a Black male, approximately 5'11" tall, and wearing a black baseball cap with a gray bill, a black jacket with vertical red stripes on the sleeves, black pants, and black shell-toe Adidas with white stripes. This investigation is continuing.

Vehicle Burglaries

There were six vehicle burglaries during the past week.

- 100 block of **Los Banos Avenue**—construction tools were taken from a 2014 **Ford F250**. The driver's door handle was damaged. Occurred on 06-05-23 at approximately 5:00 a.m.
- **Nordstrom Rack** area of the **Serramonte Shopping Center**—packages were taken from a 2012 **Workhorse Custom Chassis UPS package car**. There was damage to the interior bulkhead door. Occurred on 06-05-23 between 10:15 a.m. and 11:15 a.m. **Online report.
- Unit block of **Poncetta Drive**—a tool bag containing tools, bolts, and screws was taken from a 1999 **Chevrolet Tahoe**. Unknown method of entry. Occurred between 8:00 p.m. on 06-05-23 and 6:00 a.m. on 06-06-23.
- 100 block of **Martin Street**—phone holder and earbuds were taken from a 2016 **Mazda 3**. The passenger window was smashed. Occurred between 7:55 p.m. on 06-07-23 and 3:55 p.m. on 06-08-23. **Online report.
- Unit block of **Canterbury Avenue**—Tag Heuer watch, iPhone 10, and a pistol were taken from a 2016 **Ford Mustang**. The suspect appeared to have a key. Occurred on 06-08-23 at approximately 5:33 a.m.
- 300 block of **Bay Ridge Drive**—vehicle registration was taken from a 2015 **Toyota Corolla**. The driver's side window and front passenger window were smashed. Occurred between 6:30 p.m. on 06-08-23 and 7:00 a.m. on 06-09-23.

Stolen Vehicles

There were two stolen vehicles during the past week. Three vehicles were recovered.

- Parking garage at the **Serramonte Shopping Center**—a 2001 **Honda CRV**. Occurred on 06-09-23 between 12:00 p.m. and 1:30 p.m.
- 300 block of **Lake Merced Boulevard**—a 1999 **Toyota 4Runner**. Occurred between 5:00 p.m. on 06-11-23 and 10:15 a.m. on 06-12-23.

Miscellaneous

- There were 156 cases taken.
- There were 12 domestic disturbance cases reported.
- There were 4 cases involving an involuntary psychiatric hold.
- There were 19 malicious mischief/vandalism cases reported.
- There were 2 cases for public intoxication.
- There were 3 hit-and-run collisions reported.
- There were 11 narcotics-related cases taken.
