When I mention “the unit block” of a street, this means the incident occurred at an address anywhere between 1 and 99 of the street.

Robberies

There were five robberies during the past week.

On Tuesday, 08-15-23, at approximately 1:00 p.m., **Valliani Jewelers** at the **Serramonte Shopping Center** was a victim of robbery by three suspects. A female suspect entered the jewelry store, remained on her phone, and asked to try on a Rolex watch valued at \$38,000. A store employee asked for the suspect’s ID as collateral while she tried on the watch. As the female suspect tried on the watch, two additional suspects wearing black clothing with hoodies and full masks entered the store. The two suspects approached the female suspect and grabbed her arm while she was wearing the watch. The employee tried to prevent the suspects from taking the watch. The employee said that the female suspect voluntarily gave her arm to the two other suspects while the employee was trying to hold onto the arm of the female suspect. The two suspects were able to remove the watch and ran off. The female suspect left without her ID. All three suspects got into the same vehicle and fled. This investigation is continuing.

On Friday, 08-18-23, at approximately 5:33 p.m., on the unit block of **Westdale Avenue**, officers were dispatched to a report of a theft. While a FedEx employee was delivering packages, a white Honda Accord with tinted windows and no plates drove up to a FedEx truck. The driver remained in the vehicle while two suspects wearing hoods and masks exited the Honda, entered the FedEx truck, and took multiple packages. The employee noticed that the suspects were taking packages and approached the suspects. One of the suspects ran back to the Honda; however, the second suspect punched the employee, causing injury, and then ran back to the Honda. The Honda fled westbound on Westdale Avenue.

On Saturday, 08-19-23, at approximately 1:19 a.m., at the parking lot of the **Teglia Community Center** on **Abbot Avenue**, a victim was robbed of his satchel. The victim said he was sitting in the passenger seat of a vehicle when a suspect approached him and punched him multiple times in the face and head while another suspect either attempted to open or opened the trunk. The victim later realized his satchel containing a wallet, keys, and cell phone valued at approximately \$100 was missing. Through investigation, the satchel was located in another vehicle driven by the suspect, who attempted to open or open the trunk. The suspect who punched the victim, a 32-year-old Daly City resident, was arrested and booked into jail for robbery, battery, conspiracy, and other offenses. The other suspect, a 27-year-old Daly City resident, was arrested for robbery and conspiracy.

On Saturday, 08-19-23, at approximately 10:52 p.m., an officer was dispatched to **Lucky Supermarkets** on **Mission Street** on a report of a male who brandished a Taser. A manager of Lucky's said that he was advised by a coworker that there was a potential shoplifter. The manager observed the suspect pushing a shopping cart with two 24-packs of beer, a pack of Oreos, and laundry detergent worth approximately \$90 out into the parking lot. The manager saw a female suspect exit from a gray Mercedes-Benz and load a pack of beer worth approximately \$30 into the back of the vehicle. The manager and the first suspect grabbed the shopping cart. A minute later, a third suspect exited the vehicle with a Taser and activated it. Once the manager heard the Taser being activated, he let go of the shopping cart as he was afraid of getting hurt. All three suspects entered the vehicle and fled northbound on Mission Street. The suspect who took the beer was described as a stocky White male, approximately 30 years old, 5'7" tall, with orange facial hair, and wearing an orange beanie, tan shirt, black pants, and white shoes. The suspect who placed the beer in the vehicle was described as a slim White female, approximately 20 years old, 5'10" tall, and wearing a red sweater and dark-colored pants. The suspect with the Taser was described as a tall and broad-built Black male, approximately 30 years old, and wearing black clothing. This investigation is continuing.

On Sunday, 08-20-23, at approximately 9:38 p.m., officers were dispatched to **Lucky Supermarkets** on **Mission Street** on a report of an assault. A manager said he saw two suspects, one carrying a case of beer valued at approximately \$30, walk past registers and out of the store without paying. Both the manager and a security guard ran after the suspects. The manager said both suspects started to push the security guard with their shoulders and body. The manager ran over to help, and one of the suspects pushed the manager with his shoulder. The manager grabbed the beer, causing it to fall to the ground. One of the suspects walked behind the manager and placed him in a chokehold for a second. The security guard stated he believed that customers began to help separate the parties, and that's when the suspects left. The suspects got into a vehicle and were eventually pulled over by officers. Both suspects, a 22-year-old San Francisco resident and a 23-year-old San Francisco resident, were arrested and booked into jail for robbery.

Residential Burglaries

There was one residential burglary during the past week.

On Saturday, 08-19-23, at approximately 3:50 a.m., on the unit block of **Poncetta Drive**, a known suspect forced his way into a residence. The suspect, a 30-year-old San Francisco resident, was arrested and booked into jail for residential burglary and other charges.

Commercial Burglaries

There were three commercial burglaries and one attempted commercial burglary during the past week.

On Monday, 08-14-23, between 6:36 p.m. and 6:40 p.m., two victims had their lockers broken into at the **Crunch Fitness** facility at the **Serramonte Shopping Center**. The first victim had her cell phone, wallet, CA driver's license, Tesla key, \$400 in checks made out to an individual, \$70, and credit cards

taken. The suspect attempted to make credit card charges at a retail store, but the transactions were declined. The second victim had her rubber chicken purse, wallet, \$200, three credit cards, \$70 in miscellaneous credit cards, two pairs of sunglasses, Tiffany's pen, prescription glasses, and a Volkswagen key fob taken. The suspect attempted three credit card charges at the same retail store; one charge was approved, and the other two were declined. This investigation is continuing.

Between Tuesday, 08-15-23, at approximately 6:00 p.m., and Wednesday, 08-16-23, at approximately 7:00 a.m., **Studio Luna**, located on the 6300 block of **Mission Street**, was a victim of commercial burglary. An unknown suspect entered the business using a key from a lockbox. The suspect stole a safe containing \$5,000 and boxes of skin treatment products valued at approximately \$12,000.

Between Wednesday, 08-16-23, at approximately 6:00 p.m., and Thursday, 08-17-23, at approximately 3:14 a.m., **Cricket Wireless**, located on the 7400 block of **Mission Street**, was the victim of commercial burglary. Unknown suspect(s) stole a lockbox containing the key to the front door and used it to gain entry. The amount of loss is to be determined. This investigation is continuing.

On Thursday, 08-17-23, at approximately 2:50 a.m., an unknown suspect attempted to enter **J & K Auto Repair** located on the 200 block of **San Pedro Road**. The suspect used what appeared to be a large wrench to pry the lockbox from the door handle. The suspect then threw the lockbox on the ground multiple times in an attempt to gain access to its contents. The lockbox was empty. The suspect drove away in a silver 2010 Cadillac C350. The vehicle had a spare wheel and tire on the front right side. The suspect wore a black mask, a white hooded sweatshirt, blue jeans, and gloves.

Vehicle Burglaries

There were seven vehicle burglaries and two attempted vehicle burglaries during the past week.

- **South Hill Boulevard and Crocker Avenue**—firearm in a lockbox and ammunition were taken from a 2014 **Toyota Prius**. The rear driver's side window and rear trunk window were smashed. Occurred on 08-15-23 between 6:00 a.m. and 6:45 a.m.
- 300 block of **Chester Street**—miscellaneous tools were taken from a 2009 **Toyota Tacoma**. The driver's side window was smashed. Occurred between 11:00 a.m. on 08-17-23 and 6:45 a.m. on 08-18-23.
- 300 block of **El Dorado Drive**—wallet containing a driver's license, registration, and a debit card were taken from a 2004 **Scion**. The front passenger window was smashed. Occurred between 5:00 p.m. on 08-17-23 and 5:55 a.m. on 08-18-23. The suspect used the victim's credit card and charged \$100 at a gas station in San Francisco.
- 200 block of **San Fernando Way**—power tools and hand tools were taken from a 2008 **Toyota Tundra**. The bed cover was pried open. Occurred on 08-18-23 at approximately 2:45 a.m.
- Unit block of **Grandview Drive**—nothing was taken from a 2014 **Ford F-150**. The bed cover was pried open. Occurred between 3:00 p.m. on 08-20-23 and 5:00 a.m. on 08-21-23.
- 100 block of **Castillejo Drive**—clothes, shoes, and a \$100 Visa gift card were taken from a 2003 **Toyota Sequoia**. Unknown method of entry. Occurred between 4:00 p.m. on 08-20-23 and 11:00 a.m. on 08-21-23. **Online report.
- **Higate Drive and Southdale Avenue**—power tools and miscellaneous tools were taken from a 2010 **Toyota Tundra**. The left rear window was smashed. Occurred between 7:00 p.m. on 08-20-23 and 7:45 a.m. on 08-21-23.

- Parking lot of **Duggan's Serra Mortuary** on **Westlake Avenue**—an attempted theft from a 2012 **Chevrolet Malibu**. Occurred on 08-15-23 at approximately 7:33 a.m. There were three suspects. The first suspect, who tried to pry open the front driver's side door, was described as a Black male in his 50s to 60s, wearing a baseball cap with white writing, a black jacket over a burgundy shirt, and dark-colored pants. The second suspect was described as a White female with blonde hair wearing a plain tan sweater and blue jeans. The third suspect was described as a White female in her 40s to 50s with blonde hair and a green jacket. All suspects fled on foot northbound on Junipero Serra Boulevard.
- **Westlake Shopping Center**—an attempted theft from a 2014 **Tesla Model S**. A car door was pried and the door handle was broken. Occurred on 08-15-23 between 9:10 p.m. and 9:25 p.m. **Online report.
