



# Crime Alert and Community Update Bulletin

When I mention “the unit block” of a street, this means the incident occurred at an address anywhere between 1 and 99 of the street.

## Robberies

There were three robberies during the past week.

On Wednesday, 08-23-23, at approximately 8:10 p.m., **Zumiez** at the **Serramonte Shopping Center** was a victim of a robbery by three suspects. One of the suspects concealed merchandise valued at approximately \$375 in a bag. As employees attempted to retrieve the merchandise, two suspects spat, pushed, scratched, and hit the employees. All three suspects left the store. The first suspect was described as a Black female, approximately 20 years old, 210 pounds, 5'5" tall, with wavy brown hair with highlights, and wearing a white tee shirt and black or brown pants. The second suspect was described as a Black female, approximately 19 years old, 140 pounds, 5'6"-5'8" tall, with black hair in a ponytail, and wearing a black tee shirt and gray sweats. The third suspect was described as a Black female, approximately 19 years old, 100 pounds, 5'4" tall, with long brown hair, and wearing a black tank top and green pants. This investigation is continuing.

On Saturday, 08-26-23, at approximately 9:22 p.m., officers were dispatched to the **Burlington Coat Factory** at the **Westlake Shopping Center** on a report of a suspicious subject. A manager said the suspect entered the store and concealed approximately \$40 worth of merchandise. The manager asked the suspect to leave. The suspect waited in line to check out but could not pay for the items. The suspect then walked outside the store while still holding the unpaid merchandise. Once the suspect walked outside the store, a loss prevention employee alerted security guards. The security guards tried to apprehend the suspect. The suspect dropped a stolen item, and as the loss prevention employee went to pick it up, the suspect pepper sprayed her and fled. While officers were speaking with the manager,

security advised that a subject was yelling in the bathroom at Nick the Greek, and the description of the subject matched the suspect. Officers contacted the subject, and the Burlington Coat Factory manager identified the subject as the suspect. The suspect, a 39-year-old San Francisco resident, was arrested and booked into jail for robbery, providing a false identification to an officer, and an outstanding warrant.

On Sunday, 08-27-23, at approximately 2:27 p.m., officers were dispatched to **Safeway** at the **Westlake Shopping Center** on a report of two females who stole merchandise. A security guard stated that two suspects walked towards the exit. One suspect was carrying a basket with merchandise and the other suspect was holding merchandise in her arms. The security guard retrieved the basket with merchandise, and the store manager came to assist and began to remove items from the basket. While the security guard was focused on one suspect, the other suspect threw a drink, which hit the security guard's head. Both suspects left the store with approximately \$125 worth of stolen merchandise and fled in a vehicle. An officer located the suspect vehicle and pulled over the vehicle on Mission Street. The security guard was able to identify both suspects. One of the suspects, a 17-year-old Daly City resident, was arrested and booked into the Youth Services Center for robbery and conspiracy. The other suspect, an 18-year-old San Francisco resident, was arrested and booked into jail for robbery, conspiracy, and contributing to the delinquency of a minor.

## Residential Burglaries

There was one residential burglary during the past week.

On Tuesday, 08-22-23, at approximately 2:29 a.m., on the 300 block of **Price Street**, officers were dispatched on a report of a trespasser in the backyard. A resident said he saw the suspect in front of their door at 12:30 a.m. The resident asked the suspect to leave. The suspect left after a few minutes. At approximately 2:29 a.m., the suspect returned and broke through a backyard wooden door. Behind the wooden door was a metal gate. The resident heard the suspect bang and shake the metal gate. Officers who arrived on the scene heard the wooden door break and the metal gate shaking. Officers announced themselves, and the shaking of the metal gate stopped. The suspect ran and jumped the fences of multiple backyards. The suspect fell and was apprehended by officers. The suspect, a 27-year-old San Francisco resident, was arrested and booked into jail for burglary and resisting arrest.

## Commercial Burglaries

There were no commercial burglaries during the past week.

## Vehicle Burglaries

There were eleven vehicle burglaries and two attempted vehicle burglaries during the past week.

- 900 block of **Higate Drive**—tools were taken from a 2021 **Toyota Tacoma**. Unknown method of entry. The victim found the passenger door left open by the suspect. Occurred between 6:00 pm. on 08-20-23 and the morning hours on 08-21-23. \*\*Online report.
- 100 block of **Crestview Circle**—power tools were taken from a 2007 **Toyota Tundra**. The driver's side window was smashed. Occurred on 08-21-23 at approximately 2:15 a.m.

- Unit block of **Baldwin Avenue**—tools were taken from a 2020 **Toyota Tundra**. The rear hard top cover was damaged. Occurred on 08-24-23 at approximately 6:05 a.m. The suspect vehicle is a black Dodge Charger.
- Parking lot of **Original Joe's** on **Glenwood Avenue**—backpack containing miscellaneous paperwork was taken from a 2022 **Mercedes-Benz GLB 250**. The rear window was smashed. Occurred on 08-24-23 between 1:00 p.m. and 2:30 p.m.
- 100 block of **Ocean Grove Avenue**—toolbox, tool bags, hand tools, and a trailer ball and shank were taken from a 2003 **Ford F-150**. The retractable bed cover and locking mechanism were damaged. Occurred between 10:00 p.m. on 08-24-23 and 8:00 a.m. on 08-25-23. \*\*Online report.
- Unit block of **Dixon Court**—plumbing tools were taken from a 2020 **Ford Transit**. The passenger window was smashed and the rear compartment cage pried. Occurred between 1:00 p.m. on 08-27-23 and 6:30 a.m. on 08-28-23.
- Parking garage on the 1900 block of **Junipero Serra Boulevard**—an attempted theft from a 2020 **Nissan Rogue**. Occurred on 08-22-23 between 1:05 p.m. and 3:00 p.m.
- Unit block of **Crestview Circle**—an attempted theft from a 2023 **Audi Q4**. Three suspects wearing ski masks exit a black Dodge Charger and attempted to break the passenger window. Occurred on 08-24-23 at approximately 2:00 a.m.
