When I mention “the unit block” of a street, this means the incident occurred at an address anywhere between 1 and 99 of the street.

Robberies

There were two robberies during the past week.

On Monday, 09-25-23, at approximately 4:18 p.m., officers were dispatched to **Macy's**. A loss prevention detective stated that she saw two subjects grab items from shelves and exit the store without paying. After the suspects left the store, the loss prevention detective said she identified herself as asset protection from Macy's and attempted to tell the suspects to go to the loss prevention office. The suspects continued to walk away. The loss prevention detective attempted to detain the first suspect; however, the loss prevention detective fell to the ground. Once she was on the ground, the first suspect began to strike her in the face. Other loss prevention staff arrived and assisted in detaining the first suspect. Meanwhile, another loss prevention detective attempted to detain a second suspect and got elbowed twice in the right shoulder. The first suspect stole approximately \$860 worth of fragrance, and the second suspect stole approximately \$510 worth of fragrance. Once the suspects were detained, it was discovered they also had approximately \$2,300 worth of stolen Victoria's Secret merchandise in their bags. There was a third suspect who stole merchandise from Victoria's Secret and left the store. The first suspect, a 22-year-old San Lorenzo resident, was arrested and booked into jail for robbery, organized retail theft, grand theft, and conspiracy to commit a crime. The second suspect, a 20-year-old San Lorenzo resident, was also arrested and booked into jail for the same charges.

On Saturday, 09-30-23, at approximately 9:39 a.m., an officer was dispatched to **Dollar Tree on Mission Street** on a report of an armed robbery. The store manager stated that her cashier notified her a suspect was trying to purchase six \$500 VISA gift cards. The store manager told the suspect she could only sell him one gift card. The manager attempted to activate the gift card, but it didn't work; therefore, the suspect went to

retrieve another gift card. After activating the \$500 gift card, the suspect demanded a receipt and for the manager to open the register. The suspect then pulled a black handgun from his pocket and pointed it at the manager and the cashier. Both the manager and the cashier were scared. The manager completed the transaction, opened the register, and provided the suspect with the receipt. The suspect did not make any threats or attempt to take any money from the register; he only took the gift card and receipt and then left the store. The manager described the suspect as a skinny Hispanic male, approximately 20 years old, 5'6" tall, and wearing black gloves, a black hooded sweatshirt with the hood up, a black ski mask, gray sweatpants, and black shoes. The gift card was deactivated. This investigation is continuing.

Residential Burglaries

There were no residential burglaries during the past week.

Commercial Burglaries

There were four commercial burglaries during the past week.

On Wednesday, 09-27-23, at approximately 12:25 p.m., a suspect entered **24 Hour Fitness on Gellert Boulevard** and broke into a locker. The suspect stole a cell phone, debit cards, driver's license, Costco card, house keys, vehicle key fob, and glasses, all worth approximately \$300. The suspect was described as a heavyset Black female wearing a mask, black shirt, blue jeans, and black and white shoes. This investigation is continuing.

On Thursday, 09-28-23, at approximately 12:30 a.m., an officer was dispatched to **Wendy's on Mission Street** on a report of a burglary. A suspect smashed a glass door with a rock and made entry. Once the suspect saw employees inside the restaurant, he exited the store, picked up the rock, and ran southbound onto County Street. Later, at 2:58 a.m., the suspect, a 31-year-old Hayward resident, was arrested and booked into jail for burglary.

On Thursday, 09-28-23, at approximately 2:58 a.m., officers were dispatched to **Starbucks on Mission Street** on a possible burglary via window break. The suspect exited the rear of the building holding a safe valued at \$100. Officers located the suspect hiding in the bushes approximately twenty feet from Starbucks and apprehended him. They also located the safe with its contents rummaged through. The suspect had two rocks in his backpack and glass shards in his pants pocket. This is the same suspect mentioned above who burglarized Wendy's. The suspect, a 31-year-old Hayward resident, was also arrested and booked into jail for this burglary at Starbucks.

On Friday, 09-29-23, between 12:30 p.m. and 1:30 p.m., a suspect broke into a locker at **24 Hour Fitness on Gellert Boulevard** and stole a jacket containing car keys and house keys. The suspect used the car keys to steal the victim's 2002 Lexus ES300. The victim stated he had his wallet containing a CA driver's license, social security card, credit cards, debit card, Veterans card, and \$30 to \$40 in the glove compartment. The Lexus is the same vehicle mentioned below in the Stolen Vehicles section. This investigation is continuing.

Vehicle Burglaries

There were two vehicle burglaries during the past week.

- 200 block of **Bay Ridge Drive**—\$20 in coins were taken from a 2010 **Toyota Corolla**. The front passenger window was broken. Occurred between 6:40 p.m. on 09-26-23 and 8:44 a.m. on 09-27-23.

- Parking lot of **Original Joe's on Glenwood Avenue** —a black leather bag containing an Apple MacBook Pro and electronic number keyboard was taken from a 2023 **Chevrolet Silverado**. The rear passenger window was smashed. Occurred on 10-01-23 at approximately 12:20 p.m.

There were eight stolen vehicles during the past week. Three vehicles were recovered.

- 2200 block of **Geneva Avenue**—a 1998 **Toyota Tacoma**. Occurred on 09-25-23 at approximately 4:30 a.m. **Recovered by DCPD on 09-25-23.
- Unit block of **Bismark Street**—a 2014 **Jeep Cherokee**. Occurred on 09-25-23 at approximately 4:35 a.m.
- Unit block of **Poncetta Drive**—a 2015 **Hyundai Veloster**. Occurred on 09-25-23 between 8:30 a.m. and 12:00 p.m.
- 400 block of **South Hill Boulevard**—a 2007 **Ford Econoline**. Occurred between 7:00 p.m. on 09-27-23 and 12:00 p.m. on 09-28-23. **Recovered by CHP-Oakland on 09-28-23.
- **North Mayfair Avenue** and **Eastmoor Drive**—a 2017 **Chevrolet SS**. Occurred between 10:20 p.m. on 09-28-23 and 2:00 a.m. on 09-29-23.
- Parking lot of **24 Hour Fitness** on **Gellert Boulevard**—a 2002 **Lexus ES300**. Occurred on 09-29-23 between 12:30 p.m. and 1:30 p.m. This is the same vehicle mentioned above in the Commercial Burglaries section.
- 1000 block of **Skyline Drive**—a 2017 **Jeep Grand Cherokee**. Occurred on 09-30-23 at approximately 7:04 a.m. The suspect vehicle is a gray Lexus GS350. The victim described the suspects as Hispanic males wearing black ski masks, black hoodies, and blue jeans. The victim said one of the suspects appeared to be holding a pistol.
- Unit block of **Morton Drive**—a 2017 **Chevrolet Camaro**. Occurred between 11:00 p.m. on 09-30-23 and 7:30 a.m. on 10-01-23. **Recovered by Oakland PD on 10-01-23.

- There were 132 cases taken.
- There were 10 domestic disturbance cases reported.
- There were 4 cases involving an involuntary psychiatric hold.
- There were 7 malicious mischief/vandalism cases reported.
- There were 4 cases for public intoxication.
