



## Crime Alert and Community Update Bulletin

When I mention "the unit block" of a street, this means the incident occurred at an address anywhere between 1 and 99 of the street.

### Robberies

There were two robberies during the past week.

On Monday, 02-12-24, at approximately 2:36 p.m., an officer was dispatched to the parking lot of **Home Depot** at the **Westlake Shopping Center** on a report of a robbery. The victim said as he approached the driver's side of his vehicle, a suspect grabbed his gold chain, broke it, took the gold chain with a pendant, and walked away towards Southgate Avenue and Lake Merced Boulevard. The gold chain and pendant are valued at approximately \$3,000. The suspect was described as a Black male, 50 to 60 years old, weighing 200 to 250 pounds, with short dreadlocks, and wearing a blue shirt.

On Monday, 02-12-24, at approximately 8:58 p.m., officers were dispatched to **West Market Street** and **Mission Street** on a report of a robbery. The victim stated while he was walking home with his two friends, he was approached by three males. One suspect placed the victim in a choke hold, and then another suspect punched the victim twice in his face. The victim fell to the ground, and all three suspects began to kick the victim. The suspects took the victim's bag containing Kung Fu training gear worth approximately \$300 and fled. The suspect who placed the victim in a choke hold was described as a younger Black male wearing a black ski mask and a red and black jacket. The suspect who punched the victim was described as a younger Hispanic male wearing a yellow jacket. The victim's friend saw one of the suspects hit the victim with a gun. The friend described this suspect as a male, approximately 5'6" tall, and wearing a ski mask. An officer found replica firearm parts on the floor. This investigation is continuing.

## Residential Burglaries

There were two residential burglaries and one attempted residential burglary during the past week.

On Friday, 02-16-24, at approximately 6:20 a.m., officers were dispatched to the 100 block of **West Market Street** on a report of a female entering an open garage, entering a vehicle, and refusing to leave. The victim stated when he opened his garage door, drove his vehicle inside to park, and exited his vehicle to close the garage door, a female suspect ran inside his garage, entered the vehicle, and sat in the passenger seat. The suspect rummaged through the center console and attempted to take a \$700 ring. The victim was able to retrieve the ring from the suspect and told the suspect to leave, but she refused. The suspect then took \$40 in loose change and fled northbound on Station Avenue. A short while later, an officer located the suspect. The suspect, a 38-year-old San Francisco resident, was arrested and booked into jail for residential burglary and petty theft.

On Sunday, 02-18-24, at approximately 10:30 a.m., officers were dispatched to the 200 block of **Los Banos Avenue** on a report of a burglary that occurred between Saturday, 02-17-24, at approximately 2:00 p.m. and Sunday, 02-18-24, at approximately 10:30 a.m. Unknown suspect(s) forcefully opened two doors and cracked a lower panel of a window, causing approximately \$2,000 worth of damages. Nothing was taken.

On Thursday, 02-15-24, at approximately 12:40 a.m., officers were dispatched to the 100 block of **South Mayfair Avenue** on a report of a suspect trying to break a window to gain entrance into an apartment. A victim heard the suspect ring the doorbell multiple times and saw the front doorknob twist as if someone was trying to enter their home. The victim's husband observed the suspect holding their window screen and attempting to open their front window. The husband tapped the window from inside and said, "Hey," which caused the suspect to walk away. As the suspect was walking away, officers arrived and detained the suspect. The suspect, a 30-year-old Daly City resident, was arrested and booked into jail for attempted residential burglary and for being under the influence of a controlled substance.

## Commercial Burglaries

There was one commercial burglary during the past week.

Between Saturday, 02-17-24, at approximately 11:00 p.m. and Sunday, 02-18-24, at approximately 3:00 a.m., a suspect damaged a lock, forcefully opened a door, and entered **M & R Car Wash** located on the 1600 block of **Sullivan Avenue**. The suspect took approximately \$300 worth of coins. The suspect was described as a Hispanic person, approximately 30 to 40 years old, wearing red and black checkered pajama pants and a black jacket.

## Vehicle Burglaries

There were two vehicle burglaries during the past week.

- **Saint Francis Boulevard** and **San Miguel Avenue**—nothing was taken from a 2018 **Lexus GS350**. The front passenger side window was smashed. Occurred between 5:00 p.m. on 02-17-24 and 7:17 a.m. on 02-18-24.
- 600 block of **Cordova Street**—cleaning products, insurance papers, temporary driver's license paperwork, registration, and smog certificate were taken from a 2005 **Infiniti G35**. Unknown method of entry. Occurred between 7:00 p.m. on 02-17-24 and 7:30 a.m. on 02-18-24.

## Stolen Vehicles

There were six stolen vehicles and two attempted stolen vehicles during the past week. Four vehicles were recovered.

- **Price Street** and **Mission Street**—a 2004 **GMC Savanna**. Occurred between 12:00 p.m. on 02-12-24 and 12:26 a.m. on 02-14-24. \*\*Recovered by SFPD on 02-14-24.
- **Whittier Street** and **Hanover Street**—a 2021 **Kia Soul**. Occurred on 02-13-24 between 9:00 a.m. and 3:45 p.m.
- **Chevron** on the 2600 block of **Bayshore Boulevard**—a 2004 **GMC Savanna**. Occurred on 02-14-24 at approximately 1:20 p.m. \*\*Recovered by DCPD in San Francisco. This is the same vehicle stolen on 02-12-24.
- 700 block of **Bellevue Avenue**—a 2011 **Infiniti G37**. Occurred between 10:30 p.m. on 02-15-24 and 4:40 a.m. on 02-16-24. \*\*Recovered by Alameda PD on 02-20-24.
- 1500 block of **Southgate Avenue**—a 2013 **Kia Optima**. Occurred on 02-16-24 between 10:16 a.m. and 11:44 a.m.
- 800 block of **Brunswick Street**—a 2007 **Nissan Titan**. Occurred between 8:00 p.m. on 02-16-24 and 1:40 a.m. on 02-17-24. \*\*Recovered by SFPD on 02-19-24.
- **Winchester Street** and **Templeton Avenue**—an attempted theft of a 1999 **Ford Ranger**. Occurred on 02-12-24 at approximately 4:12 a.m.
- Garage on the unit block of **Poncetta Drive**—an attempted theft of a 2015 **Hyundai Sonata**. Occurred between 10:30 p.m. on 02-13-24 and 10:30 a.m. on 02-14-24.

## Miscellaneous

- There were 134 cases taken.
- There were 12 domestic disturbance cases reported.
- There were 8 cases involving an involuntary psychiatric hold.
- There were 7 malicious mischief/vandalism cases reported.
- There was 1 case for public intoxication.
- There were 3 hit-and-run collisions reported.
- There were 8 narcotics-related cases taken.
