

CANDIDATE PACKET for the Daly City General Municipal Election – November 5, 2024

The filing period for nomination papers for all candidates opens Monday, July 15, 2024 and closes Friday, August 9, 2024. If an incumbent does not file nomination papers by 5:00 PM on August 9, 2024, the filing period for non-incumbent candidates shall be extended to Wednesday, August 14, 2024. Candidates are encouraged to make an early appointment to receive their packet.

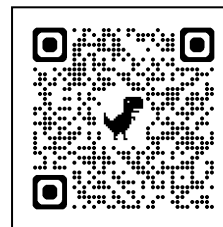
